Elderly patients from our PCN have had to get step down and step up treatment with in-beds at other hospitals and care homes throughout the county, with some even having to go hospitals out of county. End of Life Care is so important to the individual and the family. To have to spend it at a Community Hospital or Care Home somewhere in Cornwall alone with no family present is unacceptable. I think the loss of the facilities in Poltair and Edward Hain has resulted in 28 beds in our PCN not being available for in-patients. Needs our NHS staff and the community working together for a new facility in our PCN.
Individual - West Cornwall HealthWatch and SP4Cornwall	Report	Since Edward Hain lost its 12 inpatient beds in 2016, demand for such beds has risen. In 2019-20 no fewer than 75 Penwith residents aged 65+ discharged from Treliske found themselves in community hospitals distant from home. The loss of Edward Hain's beds has been partially – but only partially – offset by discharging Penwith residents from Treliske to West Cornwall Hospital. Penwith does have a hospital performing community hospital functions, but It is West Cornwall Hospital, which happens to be situated in Penzance, not St Ives.2. It has more advanced services than 'normal' community hospitals and is developing as a centre of excellence for healthcare in the West of Cornwall. It happens to be run by the Royal Cornwall Hospitals Trust, not by the Cornwall. Partnership Foundation Trust, which runs all the 'normal' community hospitals in Cornwall. At present it doesn't have enough step-down beds to meet the needs of Penwith's 65+ population.

The terms of the original trust still subsist and are capable of being complied with therefore if NHS Kernow are not going to re-open the hospital it should be transferred back to be held once again for the use and benefit of the people of St Ives in accordance with the terms of the original Trust. This hospital was never transferred to NHS as a disposable asset. That would have flown in the face of the original Trust and the Trustees could not, and would not, have transferred it on that basis. NHS PS can only sell a site if it is declared surplus by NHS Kernow. There is no basis whatsoever for a finding that this site is surplus, all the evidence points to the contrary. Section 6(4) of the NHS Act 1946 under which this property was transferred provides that the Minister shall 'so far as practicable secure that the objects for which that property was usedare not prejudiced by the operation of section 6'. Prior to the transfer to NHS the property was used for the benefit of the people of St Ives and to honour Edward Hain's name. In the current climate and present circumstances of the residents of the town it is impossible to argue that it is not practicable to use the building or sale proceeds thereof for the benefit of the people of St Ives and in remembrance of Edward Hain as per the original objects of the trust. To sell the property and move the entire sale proceeds out of county would directly prejudice the objects of the original trust.

And the burden on elderly or unwell relatives, husbands, wives, in trying to nurse really poorly people at home, is frankly intolerable. The cost/benefit analysis really needs to be done in this case, and cutting hospital provision because 'everyone prefers to be at home' is a simplistic and misguided attempt to save money which won't deliver on the savings anyway.
